## RECTOR'S LETTER

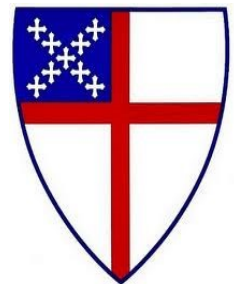
Dear Brothers and Sisters in Christ,

As I wrote this yesterday morning, at 8:21, the season of fall began. And I must admit, I got a little sad. I was having regrets for not doing more of the fun things I vowed to do when June 19th rolled in with summer. On the other hand, I did "get back up on one" in water skiing, a goal heretofore unreachable for me for the last eleven years. And I did have a fabulous vacation with all our extended family. And I did spend lots of time with my brothers, seemingly much more than in previous years. **BUILDING DISCERNMENT CHURCH MEETING RESULTS**

At a parish-wide meeting held September 11, the Vestry and Building Discernment Committee presented their reasons and a possible plan for expansion of the facilities of All Saints' Church. Comment cards were passed out to all those present at the meeting. In addition, a few days later an e-mail was sent to all those on the church mailing list with a comment card and outline of the presentation attached, as well as information on how to access a video or CD of the presentation if they desired. The comment card asks a specific question of responders: should we or should we not move forward with the expansion project, and reasons why/why not. Moving forward would involve engaging the services of a firm (at some cost) to work with us in formulating a more detailed design and cost estimate. After this is done, we would again present the information at a parish meeting to determine whether there is or is not support for an expansion project and what it might entail.

Below is a summary of the responses received to date to this question, both from the comment cards that have been turned in as well as from messages received via regular or e-mail.

NUMBER OF RESPONSES: Total 39 people.

SHOULD MOVE FORWARD: 37 people

SHOULD NOT MOVE FORWARD: 2 people

**REASONS FOR:**

The great majority of the respondents indicated support for moving forward, to, as stated by one parishioner, pursue getting a good cost estimate so "we'll have a better idea if we can afford to move forward" with all or part of the plan.

A few people indicated support for "All the reasons outlined at the presentation". These reasons fall into the following areas: handicap accessibility, increased sanctuary space for a single service, Christian education (children, youth, adult) program vitality and opportunities, Rector and administrator office needs, and space for parish gatherings and events (e.g., Memorial Hall).

The reasons that were most mentioned by those who supported moving forward are the following:

- \* Need adequate space for current needs and for all church activities
- \* Room for families to sit together
- \* Great benefits associated with a combined and single Sunday service
- \* Increased vitality and interconnectedness with combined services
- \* Enhanced sense of community
- \* Children ministries and adult spiritual education opportunities; energy and vitality increased; all children of the parish can know each other and grow together

- \* Office improvements needed – Rector, Parish Administrator – efficiency, privacy, security
- \* Music programs and choir opportunities
- \* Memorial Hall expansion needed for fellowship and social events
- \* Need “room and opportunity for potential growth”
- \* “We can’t grow without expansion.” “We can either grow or slowly die. I vote that we grow”.
- \* We should be “forward thinking”
- \* Facility for dynamic youth program and potential for growth. Need for space is “urgent”.
- \* “Our children are our future” and we need the space for growth, and the vitality of a combined congregation.
- \* Greater opportunity for offering adult Christian education classes
- \* Would need bigger kitchen and better appliances
- \* Services need to be accessible to all
- \* Handicap accessibility and for those with mobility issues

**REASONS AGAINST:**

The main reason by far that was mentioned was related to possible costs and uncertainty as to whether an expansion project would be affordable and feasible to accomplish. About a third of those who had indicated support for moving forward to the next step in this process also brought up some concerns for costs and potentially taking on debt. The changing demographics of the congregation and rate of growth were concerns mentioned by one that might affect ability to afford an expansion.

One person expressed that they have been to joint services in All Saints’ but it “was not uncomfortable” to them, even though the church was full. They didn’t “really feel the need” for a new sanctuary. They agreed that combining services “could have many social benefits”, that the current building was not accessible to those with disabilities, and that Memorial Hall should be expanded. However, they would like us to wait on the sanctuary, first try and test the ability and the advantages to combined services, for example for one Sunday a month. This concept of testing having a regular combined service in our current church was also brought up by one other parishioner as a possible idea.

One person preferred the original idea of expanding the current church building and wanted to make sure we keep our options open, and to explore the expanding of the current church building fully.

### OTHER MISCELLANEOUS COMMENTS:

- \* Need to “honor the history and heritage of the place....the “new” needs to be a part of that”
- \* “Maintain the “cozy” feel of our current church”. Keep it looking “softly Montana”, not too “sterile”.
- \* One mentioned they’d like to see the children’s education rooms located within the new church, with the thought that it would be more comfortable for children/parents and reduce costs.
- \* How does this expansion project fit in with the Diocesan Capital Campaign projects?
- \* The “money will come to fulfill needs.”
- \* “Are we building because of crowds” at special events?
- \* “Present floor space reorganized” could provide adequate office space.
- \* Landscaping needs, including thinning of trees, will be an expense.
- \* “We should use cubits as unit of measurement”.

## BLAZE THE WONDER DOG

My friend, Shawn (who just happens to be the Parish Administrator and technical guru) sent me a photo from a trip she and her dog, Blaze, took over the Labor Day weekend. I was so impressed with Blaze (well, Shawn is pretty impressive, too) that I asked her to do a little bragging. Below are Blaze's accomplishments and after you read them, you, too, will call him "Blaze the Wonder Dog."

**We went to a 3 day agility trial: The Copper Paws, in Butte hosted by the mBarking agility club. Blaze had 19 runs in 6 different classes (Hoopers, Jumpers, Regular, Tunnelers, Barrelers, Chances, & Touch N' Go ) over the course of the 3 day weekend. He earned 15 purple qualifying ribbons (which earn him points towards titles - theoretically if there were 20 dogs entered in his level and height category all 20 could get qualifying ribbons if they did what they were supposed to do in the allotted time, but then they also give out one 1st, 2nd, 3rd, and 4th place ribbon in each height category); 14 first place ribbons; 2 second place ribbons; he earned 4 title ribbons (the big rosette ones) one for Outstanding Performance in Intro Regular Agility (100 pts), one for Outstanding Performance in Intro Chances (60 pts), one for Outstanding Performance in Intro Hoopers (60 pts), and one for Superior Performance in Intro Jumpers (100 pts) (which moved him up to the Novice level); and the big acrylic plaque was for "High in Trial" in the Intro Level (there are 4 levels: Intro, Novice, Open, and Elite).**
